Dear Supervisor Acton and all,

Happy New Year! I hope this message finds you all well as we head into winter. NY State (NYSERDA) has not yet announced the results of their RFP, so we still wait on that announcement.

I wanted to provide a quick update on our progress. We've finished seasonal fieldwork (Phase 1B SHPO work, which is shovel testing; wetlands boundary confirmation with DEC), but have other ongoing work-- some of which you may have seen.

Current work underway includes:

- Ground survey (Fisher Engineering)
- Winter Raptor study (West Ecosystems)
- Sound study (data modelling portion) (Aeroustics)-completed recently

Upcoming work of importance includes setting a meeting, or meetings, with the Town to discuss several things.

- formal 94c Preapplication meeting requirements (layout discussion, visual studies, road use, historical concerns, understanding of code, other items as required)
- Initiate discussions with Town of Alfred about Host Community Agreement (HCA)
- Meeting with the fire department(s)—Shawn assisting here

Our attorney for 94c, Jim Muscato from Young, Sommer, will reach out to you soon to set up a meeting, either in person or online, according to your preference.
